# Assessing progress and identifying priorities for the implementation of the Civilian CSDP Compact

The Ministry of Foreign Affairs of Finland and the EU Institute for Security Studies

19 July 2019, Permanent Representation of Finland to the EU, Brussels

In November 2018, the Foreign Affairs Council and the member states adopted the Civilian CSDP Compact and thereby committed themselves to a more capable, more effective, and more joined up civilian CSDP. To support the full implementation of the Compact, the Finnish Presidency of the Council the European Union and the EU Institute for Security Studies organise a workshop on 19 July 2019 in Brussels. The primary objective of the workshop is to take stock of progress and contribute to identifying priorities for the work ahead by exchanging best practices on national plans and discussing crisis scenarios for civilian CSDP.

The workshop is divided into three sessions. First, a high-level panel will outline global scenarios for civilian CSDP by 2023, the deadline for the full implementation of the Compact. During the second session, participants will split into four working groups that will share best practices and identify challenges member states face in relation to the development of their National Implementation Plans. The third and last session takes the format of two parallel crisis simulation games in the Eastern and Southern neighbourhood. A summary note outlining outcomes of the workshop will be distributed after the event.
