The need to coordinate the various entities and policies of the EU in the field of security and development has been acknowledged since the very beginning of the Union's aspiration to play a role in world politics.

With the Joint Communication on the 'EU's comprehensive approach to external conflict and crises' in 2013, the High Representative of the European Union for Foreign Affairs and Security Policy (HR/VP) and the European Commission laid the foundations of a joined-up policy to more effectively respond to the causes and manifestations of instability.

The 2016 EU Global Strategy on Foreign and Security Policy seeks to move this forward by introducing the concept of an 'integrated approach to conflicts and crises'. The Integrated Approach has since become one of the Strategy's follow-up work strands (together with security and defence, resilience, the internal-external security nexus, updating existing strategies and public diplomacy).

The Seminar aims at analysing the Integrated Approach and the opportunities it creates for a more effective EU external action, in particular in Conflict Prevention and Stabilisation.
