CONCEPT

The Western Balkans region has experienced an intensification of foreign interference and disinformation over the past few years. Certain domestic, regional and international actors have sought to challenge the EU's and NATO's present and historical credibility in the region, sow disinformation about the Covid-19 pandemic and attempt to undermine elections and referenda in the region. In certain cases, foreign interference in elections has taken the form of propaganda campaigns, supported by foreign intelligence activities. Such tactics prey on historical and cultural perceptions and myths and relative fluidity with which information travels across borders in the Western Balkans.

The aim of this webinar is to assess how the EU and NATO can better cooperate with each other to counter foreign interference and disinformation campaigns in the Western Balkans. This meeting of experts from the EU, NATO and regional actors will outline and analyse the actors that are responsible for foreign interference and disinformation campaigns in the region. The webinar will also reflect on the tools and tactics used by these actors in the Western Balkans. In this respect, the webinar will engage with existing EU and NATO strategies but it will also focus on areas where EU-NATO cooperation can be enhanced. Accordingly, the discussions will be quided by the following questions:

- In what ways is the Western Balkans a target of foreign interference and disinformation campaigns? What tactics and tools are used by actors to perpetrate these challenges in the region?
- How can the EU and NATO support and work together with the region to prevent and counter foreign interference and disinformation campaigns? What new approaches can be developed?
- How do regional actors view foreign interference and disinformation campaigns in the Western Balkans region? What more do they expect from the EU and NATO as partners?
